

ORDINANCE NO 205

AN ORDINANCE AMENDING ORDINANCE 166  
RELATING TO CITY FEES AND REPEALING ORDINANCE 203 AND DECLARING AN  
EMERGENCY

WHEREAS, the Detroit City Council finds that it is in the best interest of the citizens of the City of Detroit to amend Ordinance 166 relating to fees and regulations regarding City Streets and repeal Ordinance 203

NOW, THEREFORE, THE CITY OF DETROIT, OREGON ORDAINS AS FOLLOWS:

**Section 1. Amend number 4, adding Patton Road, Santiam Avenue and Forest Avenue West of Highway 22 and Detroit Avenue N.,** which reads; the street in the City of Detroit known as Highway 22 shall be exempt from this ordinance regardless of weight. All vehicles regardless of weight may utilize this road. The streets in the City Of Detroit known as Detroit Avenue and Clester Road shall be exempt from this ordinance for delivery trucks only.

**Section 2. Remove number 5 which states:** any person who is a legal resident of the City of Detroit may travel over any street or roadway in the City of Detroit and operate a vehicle having a gross vehicle weight according to the manufactures specifications in excess of 30,000 pounds when it becomes necessary to drive said vehicle to the residence of said person, in situations where said person who operates the vehicle is loaded and can not unload his vehicle, and therefore may keep said vehicle at his residence, but such allowed overnight parking may not exceed 12 consecutive hour in a 24 hour period on any property. At no time may vehicles be parked on City Streets.

**Section 3. Amend number 8 of ORD 166; Remove** “there will be no charge for first 5 loads per month, each load thereafter will be charged \$25.00 per load “, and **add** “there will be a fee of \$30.00 per load for each load exceeding 55,000, which will be for the Street Fund.

**Section 4. Add number 9 to ORD 166:** The City of Detroit will charge a City Permit Fee of \$25.00 per project, which will be an admin fee for the General Fund.

**Section 5 . Add number 10 to ORD 166:                    Effective Date – Emergency Clause**

- 1) Upon adoption by a three-fourths vote of all of the members of the Detroit City Council, and also by the Mayor, and upon the Mayor’s signing, this ordinance shall become effective immediately.
- 2) This ordinance shall become effective immediately to protect the peace, health, safety, and welfare of the public, and the public finances and capital improvement infrastructure of this city.
