

ORDINANCE NO. 246

AN ORDINANCE AMENDING "EXHIBIT A" INCORPORATED INTO ORDINANCE 216  
SOLID WASTE MANAGEMENT – PACIFIC SANITATION INC. RATE CHANGES

WHEREAS, on the 14<sup>th</sup> day of June, 2016, the City of Detroit approved a rate increase request from Pacific Sanitation Inc. to cover increased operating costs; and

WHEREAS, Rate changes can only be done by ordinance amending "Exhibit A" per Ordinance 216 Section 13; and

WHEREAS, without the rate increase, Pacific Sanitation would continue to operate at a loss, even while cutting as many costs as necessary and still operating safely and efficiently for its customers.

Rollcarts: The collector will supply a rollcart as part of the service price. Customers will not place larger items or overfill the cart-such that the lid cannot close properly. Carts must be placed at curb or street edge with clear access within manageable reach from the street on service day. Maximum weight limits are: 180 lbs-95 gallon, 120 lbs-65 gallon, 60 lbs-35 gallon. Customers will not place hazardous chemicals, paints, corrosive materials, hot ashes and dirt/rocks into the cart.

Damaged carts due to noncompliance with the restrictions outlined above, may be replaced at a cost of \$75.00 to the customer. Damaged carts due to fire, theft, flood or other circumstances may be replaced through customer's homeowners insurance or by the hauler.
