- a. **Direct Award Guidance for Expanded Water Treatment Capacity- Matt Del Moro FEMA has accepted project for an upgrade of a second temporary water system that will produce 140 gallons per minute. Currently the system functions at a 70 gallons per minute the current system was not designed to be compatible with how many connections we currently have. FEMA is now looking at the cost of the project and that has not been approved of as yet. The cost of the renter equipment is 15,250.00 per month. 9,600.00 for models. 9,070.00 dollars for Westech to come out and program everything. 5,000 dollars to ship the equipment. The only requirement that FEMA is that the City follow the procurement plan. This writer was unable to hear a lot of what questions Council was asking do to the sound system.**
