ORDINANCE NO. 32

AN ORDINANCE ORDERING A SPECIAL ELECTION TO BE HELD ACCORDING TO LAW AND THE EXISTING ORDINANCES OF THE CITY OF DETROIT, OREGON, FOR THE PURPOSE OF ADOPTING OR REJECTING THE PROPOSED ADDITIONS TO THE CHARTER FOR SAID CITY, AND DECLARING AN EMERGENCY.

WHEREAS: The common Council of the City of Detroit, Oregon, met in a special meeting in the Detroit City Hall building of the said City upon the 29th day of June, 1966 at 7.30 P.M. All members thereof being present, and

WHEREAS: Said Council deems it necessary to propose to the people the following additions to the charter of said City, now therefor

Be it ordained by the common Council of the City of Detroit, Oregon as follows:

- 32-1 There shall be refered to the voters of said City of Detroit, for rejection or approval at a special election, which said election will be held upon the 20th day of July 1966 at the Detroit City Hall, building in Detroit, Marion County, Oregon, commencing at 1.00 P.M. and continuing until 8.00 P.M. of said day for the purpose of submitting the following additions to the charter of the City of Detroit, Oregon to the voters of said City.
- 32-1 (a) An addition to the charter of the City of Detroit, Oregon, for the purpose of providing funds for the improvements, extention, and reconstruction of the water system of the City, the common council of said City is authorized and empowered to issue and sell revenue bonds of the City of Detroit in the sum of eighty five (\$85,000.00) thousand dollars, said eighty five thousand dollars issue in addition to the fifty thousand dollar issue, as provided in section 45 of the charter dated 28, December 1954, said bonds to be in denominations not to exceed three thousand four hundred (\$3,400.00) dollars each, to be dated at a convenient date as determined by the common council, maturity or maturities shall likewise be determined by the common council, but such maturities shall not exceed twenty five (25) years from date of said bonds to bear interest at not to exceed four (4) per cent per annum, the first two annual payments to be interest only, payable annualy at the office of the City Treasurer of Detroit, Oregon, and said bonds being issued shall be signed by the Mayor and countersigned by the recorder of said City and the seal of the City shall be affixed thereto, whereby the City of Detroit shall be held in substance and effect to undertake and promise to pay the sum therein named together with interest thereon, as the bonds become due and payable, in gold coin of the United States of the present standard of value, and the couons attached to said bonds shall bear the facimile signature of said officers, which said bonds shall be known as ("City of Detroit Water Bonds second issue.") The budget committee, each year at the time of making the annual budget for the City purposes, shall make a special levy in the sum sufficient to pay interest due on the outstanding bonds of this issue and to retire the principal thereof as it matures. The debt limitation contained in the charter shall not apply to the bonds hereby authorized.

- 32-1 (b) A contract in excess of \$2,500.00 for a public improvement to be made by a private contractor shall be let to the lowest responsible bidder for the contract and shall be done in accordance with plans and specifications approved by the council.
- That the following named persons are hereby named as the election board to hold daid election, the first named person shall be chairman of said election board, that the compensation for the members of said election board is to be the sum of \$5.00.

- 32-3 The Recorder is hereby directed to give notice of said election by posting a complete copy of this ordinance, together with a full and complete copy of the notice of election and of the proposed additions to the charter to be voted upon at said election at each of four public places in Detroit, Oregon, for a period of twenty days after passage of this ordinance and prior to the holding of the election called herein.
- It is hereby ajudged and declared that existing conditions are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety of the City of Detroit, and an emergency is hereby declared to exist, and this ordinance shall take effect and be in ful force and effect when signed by the Mayor.

Whereupon the Mayor declared the motin to be unanimously carried and the ordinance adopted.
