

Ordinance Annexing Territory without an Election in the City of the Territory

SPECIAL ORDINANCE NO. 78

AN ORDINANCE ANNEXING CERTAIN TERRITORY.

WHEREAS, there has been submitted to the City of Detroit written requests for annexation to the city signed by more than one-half of the landowners who also own more than one-half of the land in the contiguous territory described below, which real property represents more than one-half of the assessed value of all real property in the contiguous territory to be annexed; and

WHEREAS, Ordinance No. 77 (Special) was passed, initiating the annexation of the territory, calling a hearing, and directing that notice be given, and

WHEREAS, after conducting the hearing and considering all objections or remonstrances with reference to the proposed annexation, the City Council finds that the annexation is in the best interest of the city and of the contiguous territory;

NOW, THEREFORE,

The City of Detroit Ordains as follows:

Section 1. Alexander Addition. The following contiguous territory known as the Alexander Addition is hereby proclaimed to be annexed to the City of Detroit:

N.E. 1/4 of the N.E. 1/4 of the S.W. 1/4; N. 1/2 of the S.E. 1/4 of the N.E. 1/4 of the S.W. 1/4; N.E. 1/4 of the S.W. 1/4 of the N.E. 1/4 of the S.W. 1/4; E. 1/2 of the N.W. 1/4 of the N.E. 1/4 S.W. 1/4; S.E. 1/4 of the N.W. 1/4, EXCEPTING that portion thereof described as follows: BEGINNING at the S.W. corner of the S.E. 1/4 of the N.E. 1/4 (SE 1/4 NW 1/4) of section 1 of said township and Range; thence N. 89°03' E. a distance of 172.3 ft.; thence N. 60°42' W. a distance of 434.5 ft.; thence N. 83°18' E. a distance of 100.0 ft.; thence N. 60°42' W. a distance of 883.0 ft.; thence S. 89°04' W. a distance of 93.1 ft. to the N.W. corner of the S.E. 1/4 of the N.W. 1/4 (SE 1/4 NW 1/4) of said section 1 of Township 10S., R-5E., of the W.M. in Marion County, Oregon; thence S. 103' W. a distance of 1,520.3 ft. to the point of beginning, being situated in Section 1, T-10S., R-5E., of the W.M., in Marion County, Oregon.

Section 2. Record. The city Recorder shall submit to the Oregon Secretary of State (1) a copy of this ordinance, (2) a copy of the statement of consent of the landowners in the territory annexed, and (3) a copy of Special ordinance No. 77 dispensing with an election in the city on the question of annexation. The City Recorder shall also send a description by metes and bounds, or legal subdivisions, and a map depicting the new boundaries of the City within 10 days of the effective date of annexation to the Marion County assessor, the Marion County Clerk, and the State Department of Revenue.

This Ordinance shall be in force and effect at the day of its passage. Ordinance read in full at the City Council meeting on September 14, 1982. Ordinance read in full and passed at Special City Council meeting held on September 28, 1982.
