

ORDINANCE NO. 68-A

REPEAL OF ORDINANCE NO. 68

AN ORDINANCE ADOPTING CERTAIN STATE STATUTES REGARDING USE AND OPERATION OF SNOWMOBILES: PERMITTING OPERATION OF SNOWMOBILES ON CITY STREETS WITHIN THE CITY LIMITS OF DETROIT: REQUIRING CERTAIN EQUIPMENT ON SNOWMOBILES WHEN IN USE ON CITY STREETS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DETROIT, OREGON:

Section 1. The City Council of the City of Detroit does hereby adopt the following Oregon State Statutes:

ORS 483.710  
ORS 483.725  
ORS 483.730  
ORS 483.735

Section 2. Snowmobiles may be operated on the city streets within the city limits of the City of Detroit subject to compliance with the aforementioned state statutes and the following regulations:

a) Snowmobile operators shall comply with all applicable traffic and vehicular laws of the State of Oregon while operating on city streets, and a snowmobile shall be considered a vehicle and its operator shall be considered a driver for the purpose of this ordinance.

b) No person shall operate a snowmobile in the City of Detroit at a speed greater than fifteen (15) miles per hour and no person shall operate a snowmobile in a reckless or dangerous manner.

c) Snowmobiles will not be permitted on the portion of Detroit Avenue and Forest Avenue which is the State Highway.


d) Snowmobiles shall not be operated on city streets after 10:00PM for recreational purposes.

Section 3. All persons operating a snowmobile on the city streets shall comply with all state equipment regulations as set forth in ORS 483.730.

Section 4. All persons operating or riding on a snowmobile within the city limits of the City of Detroit shall wear a safety helmet to the specifications as approved by the State of Oregon Motor Vehicles Division.

Section 5. Snowmobile caution signs will be posted at city streets that intersect with Highway 22.


ORDINANCE # 68

AN ORDINANCE REGULATING OPERATION OF SNOWMOBILES:

The City of Detroit, Oregon, ordains as follows:

1. The provisions of Chapter 403, Oregon Revised Statutes, relating to the operation of snowmobiles, including the applicable statutory provisions for the enforcement of such laws, are hereby adopted and shall apply to and govern the operation of such vehicles upon the public streets and public lands within the corporate boundaries of the City of Detroit; and,
2. The owner, operator, and any other person having charge or control of any snowmobile shall be responsible for the strict compliance with the applicable ordinances of this city relating to speed, noise and parking of vehicles; and nuisances, including, but not limited to, those applicable provisions of Ordinances numbered 11, 29, 37, and 53.
