  - a. Temporary Water Treatment Plat Matt Del Moro- Matt has been working with the new FEMA representative. The new representative is going over what the old FEMA representative has done. The new representative has questions about the new City Hall. Chris Epley is having conversations with FEMA around this. Should the decision be made that the City can not use the donated materials that were for city hall to of set the cost, the city will need to use the \$150,000 from the Oregon Community Grant. FEMA has approved the new temporary water treatment plant project. For the rented equipment the cost will be between \$150,000-\$300,000 depending on how long the rental is needed. The cities cost in this would be anywhere from \$15,000 to \$30,000. There is a chance that FEMA will accept the donated resources from City Hall to cover this project, so a
